Kim Stiles -NFH Board Member presentation

- Cabin owner names
- Get accurate cabin locations
- NFH sent delegation to DC (lobbyist)
- Most Tahoe fire destroyed cabins were cleaned up by FEMA
- "Impaired use" language in Cabin Fee Act being developed by Forest Service
- Evacuation length shortening "Passport System" discussed
- "Interactive cabin area" system not highly accurate
- "Cabin destroyed" Forest Service to change language
- Possible "in lieu of " relocations for destroyed cabins
- 2028 permits to be reissued, with new permit language being negotiated by NFH lawyers (like "joint ownership", etc)
- Move to preserve the cabin program in the future
- Permit language being defined between "terminate vs revoke"
- Use Apple maps to find cabins
- Shared funding 80%/15%/5%

Tony Miller – Emergency Services Director

• EMS -45 to 60 minute response time \$60/ tear for Life Flights (Seattle to Yakima) AirLift NW and Life Flight

Emergency Management System– 90% federal grants

- Hired new grant writer grant specialist to help HOA/Tracts
- Evacuation specialist for emergency services reverse 911 calls to home phones (no phones)
- Sign up for "Alert Yakima" service for cabin owners
- Tony to get ATT to repair downed tower
- Discussion about Level 2 vs Level 3 evacuation meanings
- Differences between "private vs public" emergency communications

- Public phone to call 9.1.1. at Whistl'n Jacks
- Try texting 9.1.1. on cell phone if no cell coverage seemingly available
