Rest assured that the CPCOA Board is working on your behalf with local USFS staff and members of the national association of Forest Homeowners. Our USFS district office team has remained stable and is still accessible to us via phone, email, and texts and in person with appointments.

Do you know your cabin neighbors? It would help us immensely if you could share any ownership changes with us so we can update our records and reach out to prospective members. Your assistance with this information is deeply appreciated. I would go a step further and ask you to share this letter and attached member registration/renewal with all the new owners and others in your respective tracts who are non-members. The Board is asking for Tract Representatives to present issues to the Board and recruit new members, especially new owners. If you are interested in this position, please contact me.

Several weeks ago, I sat in (virtually) on the National Forest Homeowners (NFH) annual business meeting that was being held at Lake Tahoe. Did you know that as Region 6, comprised of cabin owners in Washington and Oregon, we are the second largest region in North America with 2,726 Lots in 113 Tracts. Only region 5, which is all of California, has more with 5,983 Lots and 254 tracts. What this means is, we have influence. But to have influence, we must have dues paying members to help the NFH lobbyists in Washington DC to fight against measures that have a negative impact on our cabins. Never forget, our cabin ownership is under constant scrutiny if not actual assault.

Suzy Cyr has agreed to work on 2023 Fields Trips. A few of the ideas she is working on are geology, history, flowers, and trees. Hello Cabin Owners! Just a quick reminder that your point of contact for your cabin has changed. Also, please remember that prior approval is needed before any work can be conducted on your cabin or hazard trees can be addressed. Hazard Tree and Project Request forms are available at the Ranger Station, on our website, or by email should you need them.

• Fire season is right around the corner, now is the time to get your cabin and the land around it cleaned up from any damage winter may have brought. Some common items to do are cleaning up debris from windblown trees, raking needles, and debris from your structures, clearing off any woody material, or needles on roofs, cleaning out chimneys, and screens, etc. If you have any plans to set up a sprinkler system outside of your structure in the event of a fire, now is also the time to check those hoses, sprinkler heads, faucets, well pumps, etc. Ensure the area around your cabin is clear and accessible for fire apparatus/first responders. Also, make sure your cabin number is clearly marked, this is very useful for many different things. For burning any debris from cleaning, use your outside fire pit and keep the fire of a responsible size, this is allowed if there is not a fire ban due to elevated fire conditions. We here in the Fire program appreciate the efforts and coordination of the cabin association to keep your tracts clean and help enforce fire restrictions amongst each other and the general public. That said, please make sure to not interact with the public in any situations that may be dangerous, or you feel uncomfortable. Do not hesitate to call us to make those contacts. Have a good summer!

Preparing for a Wildfire

When to	ime al	lows:
---------	--------	-------

Keep wood pile stacked away from structures if possible.

Keep property tidy/free of clutter.

Maintain accessibility to cabin for emergency vehicles.


Rake/clear debris and litter away from all structures, including off of decks, porches, etc.

Keep driveways and parking areas free of needles and debris as they may act as a fireline, slowing or stopping the spread of fire.

Keep burnable materials from contacting structures, such as limbs touching a roof.

Upon leaving if fire is threatening: (Checklist)

Close all windows, shutters, doors, etc Shut off gas supply
Turn on any outside sprinklers if available.
Don't wait too long to leave!
When leaving, post this on door outside of cabin and fill ounfo below.

CPCOA Membership Information

As an owner of a cabin, you are encouraged to join the Chinook Pass Cabin Owners' Association (CPCOA). It's a great way to stay informed on a variety of issues that could impact the enjoyment you derive from owning your cabin. Whether it is changes in rules by the Forest Service or other government agencies, we are here to help keep you informed.



By joining the CPCOA you automatically become a member of the Washington State Forest Homeowners' Association (WSFHA) and the National Forest Homeowners (NFH), which all network together to carry our voice to the halls of Congress and to keep us informed on issues at the state and national levels. It really is a great way to keep in touch on the issues that we all share.

As an example, the unfair process regarding cabin fees that was created by the CUFFA law passed in 2000 was repealed in 2014 with a new Cabin Fee Act. The CFA eliminated periodic appraisals and extreme annual fees as well as provides a stable income stream for the Forest Service to support the Recreational Residence Program nationwide. This ensures that our cabins will remain for many generations to come!

The Chinook Pass Cabin Owners' Association works on the local level --- local issues and concerns are addressed by the forest ranger, the Washington State Department of Ecology, the Yakima County Sheriff's department, and other county officials. Through our newsletter and our two meetings each year we have an opportunity to know each other, share our love and concerns for our cabins with each other and stay informed.

Membership dues are \$75.00 for a Regular membership and \$48.00 for an Associate member, which is for another person besides a "Regular" member --- adult children, co- owners, etc. This is an increase over the past several years. WE raised our dues a few dollars as did NFH. As a member of CPCOA you are receiving group representation on the local, state, and national levels all working for your best interests in protecting your cabin ownership. In case you're wondering where the money goes, \$50.00 goes to the NFH, and \$2.00 goes to WSFHA. The rest stays with CPCOA for postage, supplies, and other expenses such as rental fees for our meeting room.
